Straight and Stalwart is pleased to announce our 2026 Scholarship.

This scholarship is available to graduating high school seniors who plan to continue their education or pursue career-applicable skills beyond high school. Approved institutions include any state college, junior college, vocational, or trade school.

Applicants must complete the scholarship application form and submit unofficial school transcript(s) along with a short essay.

The 2026 Straight and Stalwart Scholarship is an award of \$10,000 and will be paid directly to the recipient's chosen institution. Funds may be used for tuition, fees, books, housing, meal plans, or other related educational expenses.

The applicant(s) awarded this scholarship must enroll as a full-time student for the Fall 2026 term. Recipients must maintain a minimum 2.0 GPA each semester.

Eligibility: Eligibility is limited to applicants who meet all of the following criteria:

- Must be a graduating senior who receives a high school diploma
- Must have a 2.0 GPA or higher on a 4.0 scale
- Must be a citizen of the United States
- Must be a child, grandchild, or great grandchild of a combat veteran (stepchildren are eligible)
- DD214 will be required if selected as recipient. (Do not submit unless requested.)

Required Materials for a complete application:

- A completed application form
- Current or complete high school transcript (emailed to us by the high school)
- A typed, double-spaced essay (not to exceed 700 words) addressing the following prompt:

This scholarship honors the service and sacrifice of our veterans by supporting the next generation of their family members. Please share how your relationship to a veteran has inspired your ambitions or outlook on life. How will this scholarship support you in achieving your academic or career goals? Where do you see yourself in five years?

The application must be received by **March 15, 2026.**
